Camp Living Word (CLW) Staff Code of Conduct

CLW staff members represent Jesus Christ in everything they do. The testimony of our staff is to be above reproach in all ways. Staff members are to be godly examples to campers and others of genuine Christian conduct and behaviour. It should not be necessary to make an apology for any staff member's appearance or actions.

CLW staff members are expected to have: a growing relationship with Jesus Christ; a heartfelt desire to share Christ with campers; a lifestyle that exemplifies the fruit of the Spirit; an attitude of respect for CLW, it's rules and leadership; a servant's heart, along with a "team player" attitude.

- 1. Spiritual Disciplines Christian growth and maturity do not just happen by themselves. Each staff member is expected to set an example for the campers by faithfully practicing the basic spiritual disciplines of Bible reading and prayer.
- 2. Conduct We expect the conduct of all staff to be above reproach and consistent with Biblical principles. It is also expected that there be no "boyfriend-girlfriend" relationships on display among unmarried staff while at Camp. If there are questions in this area please consult with the Camp Director.
- 3. Personal Grooming As a staff member, you are expected to set a high standard for the campers in your appearance. All clothing needs to be modest and non-revealing, meeting or exceeding the standards set for the campers (see below*). Hairstyles, jewelry, etc. also need to be modest and not distracting.
- 4. Focus Your top priority as a staff member must be the campers. Time spent apart from them is a neglect of your responsibility, unless you are on another assigned duty.
- 5. Promptness It is expected of all staff members to be on time to meals, meetings, activities, and assignments. Remember, your attitudes and actions set an example for the campers.

*DRESS STANDARDS FOR CAMPERS AND STAFF: Clothing is to be modest and non-revealing so that it is not a distraction or a stumbling block to the other campers and staff. Following are some examples of what is expected:

Tops: Not extremely tight; not low-cut; no strapless tops or spaghetti straps; tops must cover the midriff, even when in motion; no offensive slogans or pictures.

Pants/shorts: Not extremely tight; shorts at least mid-thigh length.

Swimwear: Modest and non-revealing.

Underwear is meant to be worn "under". Keep it there!

Should a staff member ask a camper to change out of something that does not meet the above standards, the camper needs to be willing to change promptly. Camp Deans are available to help in challenging situations.

Doctrinal Statement

We believe that there is one God, Creator, and Sustainer of the universe, existing in three persons: Father, Son, and Holy Spirit.

We believe that the Bible is the verbally inspired Word of God, is inerrant in the original manuscripts, and is uniquely infallible, our only authority for faith and practice.

We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His substitutionary sacrifice upon the cross, in His bodily resurrection, in His victory over sin and His enemy Satan, in His present exaltation at His Father's right hand, and in His personal return, at any time, in power and great glory.
